Section 4 (1) (b) of RTI Act 2005 covers the statutory declaration of Dr. Rajat Dey, Principal, Bhavan's Tripura College of Teacher Education (BTCTE). Website: www.btcte.in.

Our College is a Private Co-educational institution which is under 2(f) and 12(B) Schedule of UGC and it is permanently affiliated to Tripura University (A Central University) since 12-05-2005. The College has a Governing Body, IQAC and Bhavan's kendra Committee as per the provisions. It runs as per the rules and regulations made by Central Government, UGC, Tripura University (A Central University), State Government SCERT & NCTE from time to time.

The college is governed by the Trust 'Bharatiya Vidya Bhavan'. The College comes under "Grant-/Non-Grant" category; therefore, financial transactions are audited by Chartered Accountant. The college has different bodies to maintain all types of discipline in the campus. All the cells or committees of the institution are under Statutory Bodies and come under section 4 (1) (b) of Right to Information (RTI) Act-2005.
