STUDENT COUNCIL POLICY

Preamble:

B.T.C.T.E Student Council is a bridge between the teachers and students. It is the medium through which the students get information about several activities of the college and get involved in them. The student council is also the voice of all students.

1. Purpose of the Student Council:

- A. Council helps in sharing student's ideas, interests and concerns with the faculty members, Principal and administrative officials of the college, which ensure smooth working of the institution.
- B. Student Council assists in planning and development of various cultural, sports, social, recreational and other educational interests of the students in the institution.
- C. The Student Council provides scope to contribute in the development of students' leadership skills, programme planning and volunteering.

2. Guidelines:

- A. This Council is completely free from political ideology or influence.
- B. The Council mainly helps in the smooth running of the curricular and co-curricular activities of the college.
- C. The Council will not have any influence on the admission, evaluation process and fee structure of any course of the college.
- D. The Council cannot challenge any decision of the Governing Body of the College.
- E. The Principal may terminate any member of the Council at any time for unethical behavior or work.
- F. The Council always strives for students' welfare and the improvement of the peaceful environment in the college.

3. Procedure:

- A. A fifteen member Student Council will be constituted at the beginning of the academic year.
- B. All the student office bearers are the nominated posts.
- C. The nomination of the CRs will be at the beginning of the academic session.
- D. The rest of the nomination will be purely on the merit of their performance during the first year.
- E. The office bearers and other members (Class representatives) are nominated by the Course Coordinator in consultation with the class mentors.
- F. Appropriate gender balance in the Council shall be given priority.
- G. Two faculty members will be nominated by the Principal as advisors to the Student Council.

3.2. Eligibility:

- A. All students belonging to the institution are eligible to be nominated.
B. A part from academic performance, leadership skills, speaking power, communication skills will also be considered as criteria for getting posts in the Student Council.
C. The candidate shall not have been subjected to any disciplinary action by the Institute authorities.

4. Key functions of Student Council:

- A. To make students responsible, accountable and participate in the development of the institute as well as into the process to develop their own personality, organizational skills and career through interactive programs.
B. To inculcate democratic values, fostering qualities of leadership.
C. To promote an environment conducive to educational and personal development.
D. To develop respect for the constitution and constitutional authorities and making them active partners in the smooth functioning of the college.
E. To represent student's interest and to organize student oriented activities and programmes.
F. To promote campus unity and quality in student life by providing entertaining activities and various opportunities for campus involvements.

5. Duration:

The tenure of the Student members in the Student Council is one year, whereas the faculty members are subjected to change on the reasons of resignation/transfer termination/ or any decision taken by the Principal in the best interest of the Student Council.

6. Student Council Meetings:

The Student Council shall meet twice in a year (once in even semester and once in odd semester). It is mandatory for the faculty members to attend meetings of the Council. The support and suggestions of the faculty members will be very useful in grooming up the leadership skills of the students in the council.


